CLOSING DATE APPROACHES FOR NOMINATIONS IN THE 2022 MUNICIPAL ELECTION

Municipal Elections Act, 1996 (s.32)

Nomination Day (August 19th from 9am to 2pm) is the final day to file nomination papers for the 2022 Municipal Election.

Nominations in the City of Stratford for the offices of:

- Mayor (1)
- Councillor (10)
- Avon Maitland District School Board trustee (2)
- Huron-Perth Catholic District School Board (1)
- Conseil scolaire viamonde (French language public district school board) (1)
- Conseil scolaire catholique providence (French language catholic district school board) (1)

may be made by completing and filing in the office of the Clerk a nomination on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100.00 for all other offices. The filing fee is payable by cash, certified cheque, money order or debit.

Candidate packages are currently available from the Clerk's Office during regular business hours.

A nomination must be signed by the candidate and may be filed in person or by an agent by booking an appointment at the City Clerk's Office, during regular business hours to August 18, 2022. On August 19, 2022 (Nomination Day) nominations can be filed between 9am and 2pm without an appointment. To book an appointment please email elections@stratford.ca. When filing, the candidate must provide photo ID which includes their name and qualifying address. If a nomination for a candidate is filed by an agent, a letter must be submitted at the time of filing which authorizes the agent to file on behalf of the candidate. The letter must be signed by the candidate and commissioned or notarized by a person authorized under the Commissioners for Taking Affidavits Act or Notaries Act. In addition to this letter, an agent must also provide a copy of the candidate's ID to be retained on file. Candidates for Mayor and Councillor are required to include endorsement signatures from 25 eligible voters in the 2022 Stratford election. Candidates are encouraged to obtain more than 25 endorsement signatures.

No person who proposes to be a candidate may solicit or accept contributions for election purposes or incur campaign expenses until a nomination paper has been filed.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, voting will be opened on the dates stated below.

Voting Period: Friday, October 14, 2022 at 10:00am to Monday, October 24, 2022 at 8:00pm.
