## NOTICE OF COMMITTEE OF ADJUSTMENT HEARING

The Stratford Committee of Adjustment will consider the following applications at a hearing to be held on Wednesday, February 21, 2024 at 4:00 p.m. in the Stratford City Council Chamber (upper level), located at 1 Wellington Street, Stratford.

## MINOR VARIANCE APPLICATIONS

### A06-24 – 179 NELSON STREET – ALEXANDER BURNETT

The purpose of application A06-24 is to reduce the exterior side yard width, interior side yard width, and rear yard depth to facilitate the development of an addition and an attached garage.

Variances requested:

1. Table 6.4.2: Regulations in the Residential Second Density (R2) Zone - to reduce the minimum exterior side yard width from 4.5 m to 4.0 m.
2. Table 6.4.2: Regulations in the Residential Second Density (R2) Zone - to reduce the minimum exterior side yard width for a garage from 6 m to 4 m.
3. Table 6.4.2: Regulations in the Residential Second Density (R2) Zone – to reduce the minimum interior side yard width from 1 m to 0.6 m.
4. 4.Table 6.4.2: Regulations in the Residential Second Density (R2) Zone – to reduce the minimum rear yard depth from 7.5 m to 5.41 m.

If a person or public body that files an appeal of a decision of the City of Stratford Committee of Adjustment in respect of the application does not make written submissions to the City of Stratford Committee of Adjustment before it gives or refuses the application, the Ontario Land Tribunal may dismiss the appeal.

If you wish to be notified of the decision of the City of Stratford Committee of Adjustment in respect of the application, you must make a written request to the Secretary-Treasurer, Stratford Committee of Adjustment, Vincent Wen, 82 Erie Street, 3rd Floor Stratford, ON N5A 2M4. This will also entitle you to be advised of a possible Ontario Land Tribunal hearing. Even if you are the successful party, you should request a copy of the decision since the Stratford Committee of Adjustment decision may be appealed to the Ontario Land Tribunal by the applicant, the Minister or a specified person or public body.
