NOTICE OF NOISE BY-LAW EXEMPTION

The Stratford Festival is seeking an amendment to their previously granted exemption from the Noise Control By-law 113-79 for outdoor performances taking place at the Stratford Festival Theatre terrace at 55 Queen Street and the Tom Patterson Theatre parking lot at 111 Lakeside Drive. Rehearsals and performances will include moderately amplified noise from speakers for voice performers, four musicians, special effects including occasional loud noises, and anticipated applause from the audience. The amended exemption would be effective Tuesday, June 29, 2021 to Tuesday, September 7, 2021 between the hours of 10:00 a.m. and 10:30 p.m.
