 - Must be drawn to scale showing all measurements in metric (metres), and containing the following information:
 - 1. The municipal address and legal description of the property;
 - 2. The existing or proposed use of the property;
 - 3. The zoning category of the property;
 - 4. The location of all existing buildings and their entrances;
 - 5. The location of all driveways and parking areas on the property;
 - 6. The location and dimensions of the frontage and all boundaries of the property on which the sign is proposed to be erected;
 - 7. The location of the proposed sign on the property;
 - 8. Other information as determined by the Chief Building Official, including architectural and structural drawings as may be necessary to determine if the building is structurally capable under the Ontario Building Code of supporting the sign or advertising device.
- □ Sign Construction Drawing
 - Details of the sign drawn to scale, including dimensions, materials, colours, text, graphics, sign area and any other information as may be required to determine compliance with this By-law.
 - Construction drawings for ground signs >1.6m (5.25ft) or projecting signs >115kg (254lbs) shall be stamped by a Professional Engineer.
