





#### Chief's Message

It is my privilege to serve as the Chief of Police for the City of Stratford, Town of St. Marys and Municipality of Perth South. The municipal partnerships that have developed since 2018 when the service expanded to include St. Marys and Perth South continues to add to our abilities to support community safety and well-being.

I am pleased to present the 2024 Stratford Police Annual Report and provide the community with an overview of the significant events and changes that have happened over the past year and provide a glimpse into what the future of policing looks like as we continue to modernize the service and ensure that we are utilizing our human and financial resources as efficiently and effectively as possible.



The governing legislation that dictates how policing operates in the Province has been updated from the Police Service Act of 1991 to the new Community Safety and Policing Act. Updates include greater police oversight and governance, amendments to police labour relations and arbitrations, and improved alignment and consistency with other government statutes to highlight just a few.

Operationally the Stratford Police Service had a busy year in 2024 as we responded to 23,379 calls for service which was down from 2023 but there are some areas of concern that we need to continue to prioritize. Officers continue to respond to mental health crisis calls (896) and overdoses (121 – 5 of which resulted in fatalities) and suicides and sudden deaths (79). The Stratford Police also responded to two firearms related homicides in 2024. One resulted in multiple casualties with two fatalities and the other resulted in one person losing their life.

Staffing continues to be the number one priority for the service as we deal with long-term absences from the frontline resulting primarily from job-related injuries. In an effort to maintain our service delivery level and provide for community and officer safety we use overtime to maintain our staffing presence. This is an expensive way to do business, it increases the workload on our available members, lessens the amount of downtime away from the frontline and increases their exposure to trauma, violence and stress. We continue to try to fill those staffing gaps and have been able to recruit good young officers. The Police Service has become very young, very quickly as currently over half of our frontline constables have less than 10 years of policing experience.

The service continues to leverage technology to improve efficiencies, enhance investigative integrity, and attempt to contain costs. In 2024 the service integrated Coplogic, Digital Evidence Management, Automated License Plate Readers and in addition to Body Worn Cameras that every frontline officer is equipped with each marked police vehicle is equipped with on-board cameras the monitor both the interior and exterior of the vehicle at all times. In 2025, the city will be investing in automated speed enforcement technology, there will be more surveillance camera coverage in areas where police calls for service are more frequent, the service will be looking to expand its drone capabilities and the Next Generation 911 dispatch system will be operational which will allow the public to text in their 911 to our dispatch center. Administratively, the service will continue to incorporate technology to streamline processes so the public can access our services when and where it is convenient for them.

2025 and beyond are going to continue to see changes implemented as we streamline business, increase efficiencies and contain costs making every effort to customize our service delivery to the communities we serve. Our members are fortunate to work in a community that values safety and security and your police service is committed to community safety and well being for our citizens and visitors alike.


#### THE BUSINESS OF POLICING:



#### FIVE YEAR OCCURRENCE COUNT





- The year of 2019 showed the highest number of occurrences generated when compared to the last six years. However, 2023 had the highest number of occurrences generated in the last six years when looking at only Stratford occurrences.
- The busiest time of day is from 10am to 3pm with an increase again at 8pm. This has been consistent over the five-year comparison.
- In 2024 Friday was the busiest day and Sunday was the least busy for occurrences generated.
- In 2024 the busiest months of the year for calls for service were May and June, and the slowest months were December and February.

- In 2024 on priority 1 calls, the average time for police to arrive was 5.15 minutes and the average time from the call until police were dispatched was 1.97 minutes. Therefore 2024 increased by 6% when compared to 2023 for average time for police to arrive. Further, 2024 increased by 5.92% for average time from call until police were dispatched when compared to 2023.
- In 2024 the fastest time for police to arrive and time until police are dispatched was the month of February and the slowest was April. January also tends to be a slower month for time it takes for police to arrive due to weather conditions and this has been consistent when comparing to previous years.
- In 2024 the fastest time for police to arrive and time from call until police were dispatched is Sunday and Friday and the slowest was Saturday.





- In 2024 the motor vehicle collisions reported to the police stayed relatively consistent when compared to 2023 and 2022.
- In Stratford there was a decrease in collisions in 2020 and 2021 which was likely due to people staying home more during the Covid-19 pandemic. 2023 and 2024 the collision rate is still lower than 2019.



In 2024 there was one fatal collision, and it was in Stratford.

- E-tickets are Provincial Offence Notices (PON) issued by the police, eg speeding. In 2024 E-ticket occurrences generated increased by 7.75% when compared to 2023. The 2231 e-tickets generated is still lower than the 2376 in 2021.
- In 2024 impaired occurrences increased by 18.06% when compared to 2023. Both 2023 and 2022 are significantly lower than the 74 impaireds that occurred in 2021. 2024 had 72 which was comparable to 2021.
- Warnings issued stayed consistent from 2020 to 2022. However, in 2023 there was an increase by 11.01% when compared to 2022. 2024 decreased by 4.42% when compared to 2023.

- Due to the Covid-19 pandemic and the stayat-home order, 2020 to 2022 showed a decrease in charges laid when compared to 2019. The reason for this is due to less HTA and CAIA charges being laid. In 2024 there was a slight increase when compared to 2023 but both years are still lower than 2019.
- In 2024 HTA charges increased by approximately 12% when compared to 2023.
- CDSA charges increased slighted when comparing 2024 to 2023. Further, there was an increase by 12.72% in 2023 when compared to 2022.



- The amount of Fentanyl and Methamphetamine seized by Stratford Police rose dramatically in 2024. The rising amount of drugs seized continues to be the trend over the last five years.


Mental health occurrences increased by 1.36% in 2024

- From 2020 to 2024 there were 121 overdoses reported to the Police. Of the 121 overdoses, five resulted in a fatality.

  Narcan was administered in 37 of the overdoses.

- In 2024 there were 435 violent occurrences reported, compared to 420 in 2023, 383 in 2022, 336 in 2021 and 317 in 2020.
- There is an average of 30 to 40 Sexual Assaults reported to Stratford Police every year. However, in 2022 there were 55 sexual assaults and in 2023 there were 44 reported to the police.
- Police investigated 5 attempt homicides in 2019 to 2024. All of these occurrences resulted in charges laid. There were no homicides in 2019 to 2023. There were two homicides in 2024 and both were solved.
- Assault Police occurrences decreased by 33% when comparing 2023 to 2022. Assaults on police stayed the same in 2024 when compared to 2023.

- Domestic disputes decreased by 9.43% when comparing 2024 to 2023.
- Charges were laid in 19% of the domestic related occurrences in 2024.
- St Marys accounted for 11.15% of the domestic related occurrences reported to Police in 2024.
- Perth South accounted for 5% of the domestic related occurrences reported to Police in 2024.

In 2024 19 % of domestic disputes resulted in charges.



- Overall property offences in 2024 decreased by 10% when compared to 2023 and also decreased by 6.6% when comparing 2024 to 2022.
- Theft from motor vehicles decreased by 24.71% when comparing 2024 to 2023. This was lower than the 404 in 2022.
- Theft of vehicles decreased by 3% when comparing 2024 to 2023.
- Break and enters decreased by 15% in 2024. However, 2023, 2022 and 2021 break and enteres were lower than 2020.

### COMPLAINTS AGAINST POLICE

Accountability and transparency go a long way to building trust between the public and the police. There are two independent civilian investigative agencies in Ontario whose mandates are to investigate the conduct of police officers or the policies of the police service.

The Office of the Independent Review Director (OIPRD) now known as the Law Enforcement Complaints Agency (LECA) investigates all complaints where a member of the public alleges that an officer has committed misconduct under the Police Services Act or the policies or services provided by the police service did not comply with the Act.

"Police officers are expected to act with honesty and integrity and not abuse the extraordinary powers and authority they are granted. Police officers are also expected to treat people with respect and to act in a manner that does not discredit or undermine public confidence in the police service." <a href="https://www.oiprd.ca">www.oiprd.ca</a>

There was 26 new public complaints initiated to the Law Enforcement Complaints Agency (LECA) in 2024. Of the 26 complaints a total of 13 were screened out by LECA as not being in the public interest to refer for investigation. Of the 13 referred to investigation two were withdrawn during investigation, eight were found to be unsubstantiated after investigation meaning there was no finding of misconduct on the part of the officers. The balance of the complaints were carried over to 2025.

The second independent civilian investigative agency in Ontario is the Special Investigations Unit which investigates incidents involving police officers where there has been death, serious injury or allegations of sexual assault where there may be criminal conduct on the part of the officer(s).

There was one SIU investigations in 2024. An individual was place under arrest and secured in a cell at the Stratford Police Headquarters. The individual subsequently exhibited signs of an overdose. The individual was administered Narcan, transported by EMS to hospital and revived. The SIU investigation determined there was no criminal liability on the officers overseeing the cell area at the time.
