MINOR VARIANCE APPLICATIONS

A06-23- 228 AVONDALE AVENUE: PLANNER - M. IVANY

Purpose: Purpose: The purpose of this application under Section 45(1) of the Planning Act, R.S.O. 1990 is to reduce the required minimum front yard depth and to reduce the minimum required planting strip to facilitate parking in the required front yard.

VARIANCE REQUESTED:

- Table 5.3.2 iv) Location of Driveways, Parking Areas and Parking Aisles to reduce the required front yard depth from 6 m to 1 m to facilitate parking within the required front yard.
- 2. Table 5.3.2 iv) Location of Driveways, Parking Areas and Parking Aisles/ Section 4.21 b) to reduce the required planting strip width from 1.5 m to 0.30 m.



A07-23 - 72 DALY AVENUE: PLANNER - M. IVANY

Purpose: The purpose of this application under Section 45(1) of the Planning Act, R.S.O. 1990 is to reduce the required minimum required rear yard depth to recognize an existing building addition that is proposed to be further renovated, resulting in a reduced projection into the required rear yard.

The subject application is required to facilitate the new lot line to be created to the rear of the subject property by Draft Approved Plan of Subdivision File# 31T18-001A.

VARIANCE REQUESTED:

1. Table 6.4.2 Regulations in the Residential Second Density (R2) Zone to reduce the minimum rear yard depth from 7.5m to 3.3 m.



A07-28 - 1067 ONTARIO STREET: PLANNER - M. IVANY

Purpose: The purpose of this application under Section 45(1) of the Planning Act, R.S.O. 1990 is to increase the maximum lot coverage, reduce the minimum required landscaped open space and to reduce the minimum width of the required parking spaces, to reduce the required number of stacking spaces associated with a restaurant drive through to facilitate the construction of two new stand-alone retail buildings and two new restaurant drive thru buildings.

VARIANCE REQUESTED:

- Table 7.4 Regulations in the Commercial Zones/ Minor Variance Decision File# A18-06 to increase the maximum allowable lot coverage from 38.2% to 41%.
- Table 7.4 Regulations in the Commercial Zones to reduce the required minimum landscaped open space from 15% to 12.6%
- 3. Section 5.2 a) Minimum Parking Space requirements to reduce the required minimum width from 2.8 m to 2.7 m
- Section 4.8 a) iii) Drive Throughs, Stacking Lanes and Stacking Spaces to reduce the required number of stacking spaces for a restaurant drive through from 10 spaces to 6 spaces.

If you wish to be notified of the decision of the City of Stratford Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer, Stratford Committee of Adjustment, Miranda Ivany, 82 Erie Street, 2nd Floor Stratford, ON N5A 2M4. This will also entitle you to be advised of a possible Ontario Land Tribunal hearing. Even if you are the successful party, you should request a copy of the decision since the Stratford Committee of Adjustment decision may be appealed to the Ontario Land Tribunal by the applicant or another member of the public.

RETAIL STORE CLOSINGS DURING EASTER HOLIDAY

Stratford's designated tourism season is May 1 to November 12 each year and does not extend to the Easter

Shoppers and merchants are reminded that under the Retail Business Holidays Act, both Good Friday - April 7, 2023 and Easter Sunday – April 9, 2023, are among the designated holidays annually when most retail stores must be closed. Minimum fines for opening businesses on prohibited days of retail operation are \$500 for the first offence, \$2,000 for a second offence and \$5,000 for a third or subsequent offence. Retail outlets may be fined up to \$50,000 or the total amount of gross sales for the holiday, whichever is greater. Enforcement of the Retail Business Holidays Act in Stratford is the responsibility of Stratford Police Services.
