#### NOTICE OF COMMITTEE OF ADJUSTMENT HEARING

The Stratford Committee of Adjustment will consider the following applications at a hearing to be held on Monday, May 29, 2023 at 3:00 p.m. in the Auditorium of the Stratford Public Library, located at 19 St. Andrew Street, Stratford:

#### MINOR VARIANCE APPLICATIONS

A09-23- LOT 57 BRITANNIA AVENUE: PLANNER - M. IVANY

The purpose of this application is to reduce the minimum lot area for a corner lot from 450 m2 to 350.8 m2 to facilitate the construction of a 2 storey, semi-detached dwelling. The subject lot is contained in a Draft Approved Plan of Subdivision (31T19-001).

Variance requested:

1. Section 6.4.2 – Regulations in the Residential Second Density (R2) Zone, to reduce minimum corner lot area from 450  $m^2$  to 350.8  $m^2$  for a semi-detached dwelling.



#### A10-23 – 173 WILLIAM STREET: PLANNER – M. IVANY

The purpose of this application is to increase the maximum height of a dwelling to facilitate the construction of a single detached dwelling and to reduce the minimum interior side yard width for an accessory structure to facilitate the construction of a detached garage. The subject lot is currently vacant.

Variance requested:

- 1. Table 6.4.2 Regulation in the Residential Second Density R2(1) Zone to increase the maximum height from 10 m to 11.76 m to facilitate the construction of a single detached dwelling.
- Table 4.1.4 Accessory use Regulation, to reduce the minimum interior side yard width from 1 m to 0.15 m to facilitate the construction of a detached garage.




# CONSENT APPLICATIONS

#### B01-23 & B02-23 - 172 FREDERICK STREET & 473 DOURO STREET: PLANNER - M. IVANY

The purpose of application B01-23 is to sever the northeast portion of the subject lands at 473 Douro and 172 Frederick Street to create an industrial building lot. The proposed lot will have an approximate frontage of 34 m, depth of 59.49 m and lot area of 2,033.1 m2. A zone change will be required as a condition of approval to recognize the reduced lot depth of the lands to be severed. The lands to be severed are currently vacant and will have frontage and road access onto Douro Street.

The purpose of application B02-23 is to sever the southern portion of the lands at 473 Douro and 172 Frederick Street to create an industrial building lot. The proposed lot will have an approximate frontage of 20.91 m, depth of 38.97 m and area of 814.6 m2 and will have frontage and road access to Frederick Street. A zone change will be required as a condition of approval to recognize the reduced lot area, frontage, depth and to scope the permitted uses on the lands to be severed. The lands to be severed are currently vacant and will have frontage and road access onto Frederick Street.

The lands to be retained will have an approximate frontage of 49.63 m, depth of 133.32 m and area of 9,719.3 m2 and will have frontage and road access to Douro Street and Dover Street. The proposed lands to be retained contain an existing industrial building that is proposed to remain unchanged.

If a person or public body that files an appeal of a decision of the City of Stratford Committee of Adjustment in respect of the proposed consent does not make written submissions to the City of Stratford Committee of Adjustment before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.

If you wish to be notified of the decision of the City of Stratford Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer, Stratford Committee of Adjustment, Miranda Ivany, 82 Erie Street, 3<sup>rd</sup> Floor Stratford, ON N5A 2M4. This will also entitle you to be advised of a possible Ontario Land Tribunal hearing. Even if you are the successful party, you should request a copy of the decision since the Stratford Committee of Adjustment decision may be appealed to the Ontario Land Tribunal by the applicant or another member of the public.

# NOTICE TO PROPERTY OWNERS DESTROY NOXIOUS WEEDS - REMINDER

NOTICE IS HEREBY GIVEN to all property owners in accordance with the Weed Control Act Ontario, that unless noxious weeds growing on their lands within the Municipality of Stratford are destroyed by June 1, 2023 and throughout the season, the Municipality may enter upon said lands and cause the noxious weed or weed seeds to be destroyed, charging the costs against the land in taxes as set out in the Act.

In the interest of public health, the noxious weeds requiring eradication include Giant Hogweed, Ragweed and Poison Ivy. Other noxious weeds requiring eradication include European Buckthorn, Thistles, Jointed Goatgrass, and others as designated under the above Act.
