NOTICE OF APPLICATION AND NOTICE OF PUBLIC MEETING

ZONING BY-LAW AMENDMENT - Z03-23 - 160, 169 AND 172 FREDERICK STREET AND 473 DOURO STREET

The City of Stratford is considering an amendment to the City's Zoning By-law No. 10-2022 for the lands described

The application affects the property with the municipal address of 160, 169 and 172 Frederick Street and 473 Douro Street, Stratford. The amalgamated site is located on the north side of Frederick Street and south side of Douro Street between Romeo Street South and Burritt Street, having an area of approximately 1.40 ha (3.46 ac). The proposed Zoning By-law Amendment is rezone the property from a General Industrial ("I2") zone to a site specific General Industrial ("I2-XX") zone, applying additional provisions, as followed:

- A minimum lot frontage of 20 metres for lands describes as 'Retained Parcel', being part of 473 Douro Street
- A minimum lot depth of 55.0 metres for lands described as 'Parcel #1' being a northeast area of 473 Douro
- To lands described as 'Parcel #2' and addressed 172 Frederick Street:
 - o To limit the permitted uses to:
 - Agricultural equipment sales or rental establishment
 - Animal shelter
 - Building materials yard
 - Business office or professional office of a consulting engineer or surveyor
 - Contractor's yard or shop
 - Data centre
 - Equipment rental establishment
 - Factory store
 - Scientific or medical laboratory
 - Service trade
 - Veterinarian clinic
 - Warehouse
 - o To permit a minimum lot area of 800 square metres
 - o To permit a minimum lot frontage of 20 metres
 - o To permit a minimum lot depth of 38 metres
 - o Notwithstanding Section 12.2 hereof to the contrary, the lands zone I2-____ (169 Frederick Street) shall be used for required off-street parking for 172 Frederick Street
- To lands described as 'Parcel #2' and addressed 169 Frederick Street:

 o Notwithstanding Section 12.2 hereof to the contrary, the lands shall be used for no purposes other than a parking area for 172 Frederick Street.




ZONING BYLAW AMENDMENT - Z02-23 - 203 AND 209 WATERLOO STREET SOUTH

The City of Stratford is considering an amendment to the City's Zoning By-law No. 10-2022 for the lands described below. The application affects the property with the municipal address of 203 and 209 Waterloo Street South, Stratford. The subject lands are located immediately north-east of the intersection of Falstaff Street, Waterloo Street South and Downie Street; west of Nile Street; and, south of the Douro Street. The site is currently zoned Centre Commercial with site specific exemption 7 ("C3-7"). The purpose of this zone change is to add the use of 'Cluster Townhouse Dwelling' to the existing site specific zone; to reduce the front yard and exterior side-yard setbacks specifically for stairs/steps; and, to provide a maximum exterior side-yard setback of 5.0-metres, provided that a deck, porch or stoop project a minimum of 1.5-metres into the front yard setback.
