NOTICE OF PUBLIC MEETING REGARDING ACCOMMODATION LICENSING BY-LAW FEE IMPLEMENTATION

Date and Time of Meeting: Monday, March 25, 2024 at 7:00 P.M.

Location: Council Chambers in City Hall, 1 Wellington Street, Stratford

Purpose of the Public Meeting: The City of Stratford invites public input on the establishment of fees for the administration of the City's Accommodation Licensing By-law 130-2022. Such fees would be established in accordance with the Municipal Act, 2001, S.O. 2001, c. 25. This meeting will discuss the proposed fees necessary for the licensing, regulation, and governance of Short-Term Rental Accommodations (STRAs) and other accommodations as outlined in the By-law. The establishment of such fees would require an amendment to Schedule "B" of the City's Fees & Charges By-Law 117-2023.

The City of Stratford has evaluated the licensing fee structure based on service cost analysis and a comparison with other municipalities. It is proposed that the fees associated with obtaining a licence under the City's Accommodation Licensing By-law be as follows:

iv)	Appeal Fee (Short Term Rental & Bed and Breakfasts)	\$180.00

NO OVERNIGHT PARKING (2AM-6AM) - REMINDER

Drivers are reminded that overnight parking in the City of Stratford is not permitted on any roadway, shoulder, or City parking lot between 2:00 a.m. and 6:00 a.m., unless otherwise designated. Parking in a manner which obstructs municipal snow clearing operations is also prohibited. This is even more important during significant snowfall events to ensure that City snow plow operators can safely and efficiently clear roads. Parking in a manner which obstructs municipal snow clearing operations and/or parking overnight (between 2 a.m. and 6 a.m.) each carry a set fine of \$80, or a \$60 voluntary payment if paid within 7 days.

Stratford Police Services enforce this restriction and should be contacted if there is an overnight parking situation at the non-emergency line of 519-271-4141.
