#### Chief's Message



The daily work of the staff of the police service is unpredictable, complex, physically and emotionally demanding, sometimes dangerous and always changing.

The Stratford Police Service has a proud history of providing service to the residents and visitors to Stratford since 1854. While policing has undergone substantive changes in the past 165 years the commitment of the men and women of the Stratford Police Service has been and continues to be to serve and protect the fundamental rights of all people. On behalf of the Stratford Police I am proud to present the achievements of the service in this 2017/2018/2019 Annual Report.

The workload of the Stratford Police Service, which as of November 2018 now includes St. Marys and Perth South, continues to increase with officers responding, on average, to over 70 calls for service each day with the Communications Centre fielding an additional 40,000 calls/year from the public requesting information and advice on policing issues.

Traditional policing required officers to investigate crimes related to violence, property offences and traffic investigations. The workload of today's officers involve more call related to social issues including mental health, addiction, homelessness, family disputes and self- harm. These call types are much more labour intensive and difficult to resolve. As many of these interactions with the public do not involve any enforceable contravention of the law, police officers collaborate with partner agencies within the community to find solutions that will increase individual and community safety. The implementation of the Mobile Crisis Rapid Response Team concept in October, 2019 has greatly enhanced our service delivery to vulnerable people within our communities and provided alternatives to the cycle of institutionalization that so often occurs.

Motor vehicle collisions investigated by SPS officers increased from 744 in 2017 to 877 in 2018 (two of which resulted in fatalities) and 1014 in 2019 (four of which resulted in fatalities). During the same time periods our officers arrested an impaired driver every 10 days indicating that impaired driving by alcohol and drug is still an issue in the community. We will continue to focus our energies on promoting voluntary compliance to the traffic laws, increasing our visibility in high collision areas and leveraging technology where appropriate.

We continue to engage subject matter experts to help us improve our investigations of sexual assault to ensure we use a victim centered approach and trauma informed interviewing techniques. Victims need to know that they will be believed and that their needs are our priority.

Policing is a rewarding profession but it exposes our members to traumatic events that most people will never see or could ever imagine. It takes a toll on our members. Having a healthy workforce means that your officers are ready, willing and able to help you when you need us most. Enhanced support services for our members are vital to the health and safety of our communities. To that end and with the support of the Stratford Police Association and the Stratford Police Services Board we have provided improved access to professional services and support for physical fitness as a positive coping mechanism.

There is more work to be in done in 2020 and beyond to continue to build public trust. Examples of what we are working on are as follows:

- Modernization of training, equipment, technology and processes to increase efficiencies and provide the most effective service possible are all being investigated.
- Increased collaboration with stakeholders including other service providers will promote a more coordinated approach to helping our common client base.
- Exploring further opportunities to improve our service delivery model and contain our costs.
- Better utilization of analytics to predict crime and traffic activity so we can proactively have the right resources in the right places at the right times and be a deterrent through community visibility.
- Encouraging our members to be part of the community instead of being seen as separate and apart from the community be increasing our volunteerism and public engagement.
- Providing members with opportunities to enrich their careers through the rotation of positions, continuing education and secondments outside the organization.
- Creation and implementation of an Auxiliary Unit to support frontline policing and assist with community event

On behalf of the members Senior Command (Deputy Gerry Foster/Inspectors Mark Taylor and Jason Clarke) and all sworn and civilian staff of the service I want to thank the communities of Stratford, St. Marys and Perth South for you support and commitment to a safer community.


#### THE BUSINESS OF POLICING:





#### Five Year Occurrence Count




- 2019 has shown the highest number of occurrences generated when be compared by hour, day of week and by month for the last five years. The main reason for this is the take over of policing Perth South and St Marys.
- The busiest time of day is from 9am to 9pm with the busiest time being at 3pm. This has been consistent over the five year comparison.
- In 2019 Friday and Saturday are the busiest days and Sunday is the lowest for occurrences generated.
- The busiest months of the year are July and August and the lowest month is December.





- Provincial Offence Notices (PON's) had a large increase mainly due to policing Perth South which is a jurisdiction that consists of a lot of Police initiated occurrences such as traffic enforcement. A similar trend can be seen with impaired drivers.
- Stratford had a 15.74% decrease in e-ticket occurrences generated. While there has been 34.28% increase in warnings given.

## Enforcement – Charges Laid

Charges increased
by 30% when
compared to 2018
and 19% compared
to 2017

- Criminal Code charges has decreased when comparing 2018 and 2019 to 2017 even with the take over of St Marys and Perth South.
- CDSA has decreased and one reason for this is the introduction of the Cannabis Act and the decriminalization of marihuana. In 2017 there were 94 possession of cannabis charges laid under the Criminal Code as compared to 26 charges under the Cannabis Act.
- HTA charges shows a 50% increase over 2018 and this is mainly due to the take over of Perth South and St Marys.

Overdoses have increased over the past three years from 8 to 17 and 19

- Mental health and addiction related calls for service continue to increase. With the support and leadership of the Huron Perth Health Care Alliance, 2019 saw the implementation of the Mobile Crisis Rapid Response Team that partnered Mental Health Caseworkers on patrol with Police Officers.
- Opioid related overdoses and deaths continue to be on the increase. Officers and other frontline first responders now carry and administer Naloxone to counteract opioid overdoses and save lives.
- Every missing person report immediately initiates an investigation with technology playing a significant role in tracking and locating individuals to ensure their safety.

Suicides including attempts have went down with 33 in 2017, 30 in 2018 & 20 in 2019

## Violent Offences

- In 2018 the Police Service introduced the Advocate Case Review process for sexual assault investigations. Each sexual assault, where a charge is not laid, is reviewed by local subject matter experts outside of the police service with the goal of increasing public trust by supporting a victim centered, trauma informed approach to the investigation.
- Investigators are now better trained to understand the impact of trauma on victims and how best to support them through the investigative process to improve outcomes.



- In 2019 property offences showed a decrease when compared to 2018 even with the take over of Perth South and St Marys and the main reason for this is because of the Canada Revenue(CRA) Scam that was ramped up in 2018. There were 529 frauds reported in 2018 and a large portion of those were CRA or similar type scams.
- Stolen vehicles are increasing every year. Stolen vehicles include cars, trucks, ATV's and other motorized agricultural vehicles. Perth South experienced a disproportionate percentage of those thefts in 2019.
- Break, enter and theft occurrences are mostly populated by entries into unlocked shed and garages where power tools and bicycles are
  most often stolen. These are primarily incidents of opportunity. An increased emphasis on crime prevention strategies like Lock it or
  Lose it is needed.

#### Complaints Against Police



Accountability and transparency go a long way to building trust between the public and the police. There are two independent civilian investigative agencies in Ontario whose mandates are to investigate the conduct of police officers.

The **Office of the Independent Review Director (OIPRD)** investigates all complaints where a member of public alleges that an officer has committed misconduct under the Police Services Act.

"Police officers are expected to act with honesty and integrity and not abuse the extraordinary powers and authority they are granted. Police officers are also expected to treat people with respect and to act in a manner that does not discredit or undermine public confidence in the police service." www.oiprd.ca

Stratford Police officers interact with members of the public hundreds of thousands of times during the course of their duties and while off duty. For the last three years there have been only 5 or 6 complaints/year from the public about the conduct of our officers.

The **Special Investigations Unit (SIU) is** a civilian law enforcement agency which investigates incidents involving police officers where there has been death, serious injury or allegations of sexual assault where there may be criminal conduct on the part of the officer(s).

Sworn members of the Stratford Police Service were involved in 2 incidents in each of 2017 and 2018 that resulted in the SIU investigating the actions of the officers while in 2019 there were no investigations that required investigations by the SIU.
